# **The goal** of the Foundation is to present:

A Christian charity providing financial, organisational, educational and material assistance, as well as spiritual support and guidance, for the benefit of people who are distressed, impoverished, unemployed and in need.

#### The Foundation shall accomplish its objectives by:

- 1. Providing financial, environmental and educational assistance to natural persons who are in need of such assistance due to their financial situation in particular by:
- 1.1. providing non-refundable financial assistance and assistance in kind to the indigent, within the limits allowing levelling of social discrimination resulting from their poverty,
- 1.2. organizing educational and integration activities, gratuitous or payable within the limits of direct operating costs, aiming at increasing the level of education among the indigent and at accustoming them to independent and active functioning in the society, with particular consideration of foreign languages tuition,
- 1.3. organizing and providing on the basis of the Christian patterns of behavior, psychological and spiritual assistance, gratuitous or payable within the limits of direct operating costs, to people who are in a difficult life situation.

- 2. Cooperation with institutions of social assistance, hospices, organizations, associations, churches, institutions and natural persons who have similar or the same objectives as the Foundation, in particular by:
- 2.1. exchange of information and experiences regarding providing assistance to people who are in need,
- 2.2. organizing collective charity actions for the benefit of the indigent,
- 2.3. organizing seminars, discussions and environmental meetings, gratuitous or payable within the limits of direct operating costs, aiming at popularization of knowledge and skills concerning charity activity.
- 3. Popularization of moral patterns based on Christian cultural values by means of organizing direct meetings and of publishing and media activity.
- 4. Propagating Christian awareness among people in need of spiritual assistance.

# Rules, forms and the scope of statutory work of the Foundation

The Foundation accomplishes its statutory aims by providing material, financial, environmental and educational help to natural persons who, due to their financial situation, are in need of such assistance.

In 2019, the Foundation accomplished its aims in the scope of providing material, financial, organizational and educational assistance to the indigent, unemployed and needy, according to its statute, by means of:

- supporting and maintaining contact with families and individuals, who are under the Foundation's care, during regular meetings and home visits,
- providing financial help to those who are in need,
- providing material help, organizing the distribution of donations among those in need.

In the scope of charity activity, the Foundation accomplished its objectives by means of:

- acquiring donors and partners who support the Foundation's statutory works,
- recruiting volunteers for fulfilling projects run by the Foundation "Social Aid Program", "Life Impact", and "Soup Kitchen",

• cooperation with entities whose objectives are similar to those of the Foundation, such as "Food Bank" Foundation and other charities, SHOM ("Spouses of Heads of Mission") association, as well as various churches including the International Christian Fellowship.

In the scope of preserving ethical and moral patterns of behavior in the society by propagating Christian values and culture, the Foundation fulfilled its objectives by:

- providing spiritual support via home visits to those in need and organizing meetings for the Foundation's whole community,
- conducting meetings for women at the Warszawa-Grochów prison and for male patients of the 'Atlantis' rehabilitation dept. at Warszawa-Białołęka prison,
- organizing musical performances during the Foundation's community meetings, mail follow-up with attendees of prison workshops, providing spiritual support to patients of the Grochowski Hospital.

In 2019 the Foundation accomplished its statutory objectives within the framework of the four following projects:

## "Social Aid Program"

This project includes providing material, financial, and emotional support, as well as spiritual guidance, to families and individuals in difficult circumstances.

In 2019 the Foundation regularly supported families and individuals from the Mazowiecki region (within 100 km range of Warsaw), providing goods and financial help for meeting current needs: payment of bills, purchasing of food, medicines, household commodities and utensils.

In addition to our monthly Community Meetings, where the families the Foundation supports receive material aid, in 2019 WVM continued organizing weekly faith-based meetings, where the main focus was on providing emotional and spiritual support. There was an average attendance of 40 adults and kids from the Social Aid Program per meeting.

In 2019 the Foundation also took further steps towards forming an outreach group for those who have benefited for some time from WVM's "Social Aid Program". The goal of this initiative is not only to provide an opportunity for enhanced mutual support, but also to create a platform for these achievers to give a helping hand to others who presently struggle as they once did. Thanks to this initiative more members of the Aid Program have been taking initiative to help others who are in need.

Besides organizing weekly group meetings and individual ones for families in need at the International Community Centre, we also arrange home visits. In 2019 we organised a total of approx. 70 home visits and aid deliveries to members of our "Social Aid Program".

From the 1<sup>st</sup> till the 5<sup>th</sup> of May 2019 WVM held its fifth "Soul Shelter" spiritual retreat, this time by the Polish seaside. Six single mothers from WVM's "Social Aid Program" attended along with four of their children. One volunteer & three staff members also attended. The trip lasted five days, and it was another successful retreat, thanks to which the attendees felt strengthened spiritually and emotionally. During the trip we also organized baptisms for each of the adult participants.

In 2019 the Foundation organized its fifth annual Summer Camp, for the second time in Łeba; a town at the Polish seaside. 96 adults and children from our "Social Aid Program" enjoyed a complimentary one week holiday. The camp was again primarily financed by the Spouses of Heads of Mission (SHOM), with additional support from the First International Baptist Church in Copenhagen (FIBC), and the American School of Warsaw (ASW). A team of six Volunteers from Warsaw and FIBC, as well as three WVM staff, joined to help run the camp, giving a total of 105 attendees.

Around 240 individuals were supported through the "Social Aid Program" in 2019.

## "Life Impact" Project

This project includes support and meetings in prisons for women in Grochów and for men from the 'Atlantis' therapy group in Warszawa-Białołęka.

Meetings for women took place once a week on Fridays at the Grochów penitentiary. There was an average attendance of seven women per meeting and we generally met with two groups each time. Each woman attended the meetings approx. eight times, and in total around 60 women were supported through this project in 2019.

Meetings for men were held at the "Atlantis" therapy department of the Białołęka prison each Friday. The average number of attendees per meeting was 15 people.

Each attendee joined the meetings approx. eight times, and in total around 70 individual prisoners were supported by the Foundation.

As a part of the "Life Impact" project, the Foundation conducts correspondence with people in prisons, providing emotional support and giving advice that encourages

socialization and a restoration of prisoners' moral attitudes. In 2019 we received and responded to around 35 letters.

About 80% of individual attendees in prison meetings made a salvation decision to receive Christ and follow His teachings.

Some of the ex-prisoners, who formerly took part in our workshops, subsequently participate in our weekly faith-based meetings in Warsaw.

# "Soup Kitchen"

In 2019 this project continued to develop. Soup kitchens were organized each Monday for the neediest people in the Piaseczno area. From October 2019 Soup Kitchens were also organised every second Wednesday. About 50 people attended each Soup Kitchen.

"Open Market" Actions were also organized once a month, on Saturdays, for those in Piaseczno who were most in need of support. During these events, in addition to a warm lunch, the attendees also received clothing, household items, food products, toys etc.

The main Volunteer group for the Saturday Actions were students from the British School of Warsaw. The Monday and Wednesday Soup Kitchens were organised by mums of students from the American School of Warsaw and the British School of Warsaw.

Around 100 individuals were supported on a regular basis through this project.

#### "Hospital Support Program"

In 2019 WVM staff continued to meet with patients at the Grochowski hospital on a weekly basis. The main departments visited were the cardiology and the neuro- rehabilitation departments. The purpose of this project is to give hospital patients the possibility to talk about their struggles, as well as receive emotional and spiritual support. We also offered material assistance to those who have such a need. Our staff met with approx. 4 patients per week, and approx. 60 patients benefited from this project.

# In 2019 approx. 600 individuals directly benefited from the activity of the Foundation.

## Other activity:

<u>Community Meetings</u> - 12 successful meetings were held at the "International Community Center" where those under the care of WVM received material support primarily in the form of; food, clothing, household items, toys, hygiene products etc. They also received needed emotional and spiritual support through group and individual discussions. On average 100 people attended each meeting.

<u>Food Bank</u> – ongoing partnership, resulting in regular distribution of basic groceries to all members of the "Social Aid Program".

<u>"Stow. SHOM"</u> – ongoing cooperation with the SHOM association, which supported WVM's projects in 2019. They primarily helped us by donating a percentage of the profit from their annual Charity Bazaar to our Foundation. These funds were designated towards our Annual Summer Camp. They also supported our work through co-hosting our annual Charity Ball for the fourth consecutive year.

<u>Aid distributed via other partners</u> - about 10 small truckloads of clothing, household appliances and furniture etc. distributed mainly through the "Radość" Foundation.

# <u>Service opportunities provided</u> – 6 main groups:

- Student volunteers from 3 International Schools in Warsaw;
- Adults and young adults from expat community in Warsaw;
- ICF (International Christian Fellowship) attendees;
- Stabilized former (and some current members) of WVM Aid Program;

- Ambassadors and their spouses and other members of the diplomatic community.
